Introduction

This booklet sets out the fees for UK Centres of Excellence and Academy approval through to registration fees for IOEE professional qualifications and SFEDI Awards regulated qualifications.

This pricelist relates to qualifications open for registration during the period of 1 September 2016 to 31 August 2017.

IOEE reserves the right to make changes to approval and/or registration fees however any changes will be communicated to centres and academies in writing.

To offer any IOEE professional or regulated qualifications a Centre or Academy must be approved as detailed in the application guidance notes and receive "Approval" status.

A Centre of Excellence and Enterprise Academy approval runs for three years from the approval date.

Approval support from IOEE includes;

- Expert advice from an IOEE Enterprise Development Expert and Quality Manager
- Access to IOEE online learner registration system
- Registration system training
- Welcome Pack and Centre Approval Certificate

The approval fee for the IOEE Enterprise Academy includes approval for one of the following combinations of products:

- IOEE will provide recognition for 5 programmes
- 5 qualifications
- A combination of 5 recognised programmes and/or qualifications

On occasion an organisation may require additional support prior to making their application, we can provide a pre-approval engagement visit in order to meet these needs.

The visit would enable the organisation to understand fully the requirements of the IOEE application process and provide an opportunity for IOEE to discuss the organisations current position and how best to approach the application. **Approval Details**

- Developing and facilitating the acquisition of knowledge and skills within the Enterprise discipline in an academic environment, for example teaching or lecturing, scholarly research supervision or management of academic programmes.
- Managing the conduct of scholarly activity and/or undertaking research in any defined area of Enterprise, or in another area, but with significant impact or focus on Enterprise.
- Those with significant influence and responsibility for managing and overseeing the delivery of academic provision (e.g. heads of departments and deans of faculties).
